19 A further Complex Case Management Conference (CCMC) for this matter was held on
20 February 4, 2011 at 11:00 AM. Plaintiffs Lavon Godfrey and Gary Gilbert (“Plaintiffs”)
21 appeared through their counsel Lisl R. Duncan of Weinberg, Roger & Rosenfeld. Defendant
22 Oakland Port Services Corporation (“Defendant”) appeared through its counsel Jay Ian Aboudi.

23 Having considered the comments and proposals of the parties presented at the CCMC, the
24 Court hereby ORDERS:

- 25 1. *Conferences.* The Court scheduled the next Complex Case Management
26 Conference for February 25, 2011 at 11:00 AM in Department 20. In lieu of an updated CCMC
27 Statement, the parties are to submit a joint status report regarding an amended proposed class
28 notice and approval of the class notice process in compliance with California Rule of Court

1 3.766. The joint status report shall be filed and served by February 22, 2011 with a hard
2 courtesy copy sent to Department 20.

3 2. *Trial.* A Jury Trial date is scheduled for November 29, 2011 at 9:30 AM in
4 Department 20 which shall commence with jury selection or, should a trial by jury no longer be
5 applicable, with the presentation of evidence.

6 3. *Trial Management Conference.* A Trial Management Conference is scheduled for
7 November 10, 2011 at 3:00 PM in Department 20. All documents, motions, and lists pursuant to
8 Local Rule 3.35, if applicable, shall be filed and served with a hard courtesy copy sent to
9 Department 20 by November 3, 2011 in preparation for the Trial Management Conference.
10 Motions in Limine (or other pre-trial motions), expert witness disclosures, and separation of
11 issues between Court and jury shall, and any other necessary briefing shall be completed by
12 November 10, 2011.
